Live Remote Proctor: Important Notes

SETUP

This exam requires a closed room with window coverings, free from distraction or interruption. Testing in an open concept room is not permitted. Make sure your external webcam is placed to show your face, hands, keyboard, area surrounding your keyboard (about 10 inches). You must have a table/desk and chair to take the exam. Testing on a couch, bed, or floor is NOT permitted. You will be required to perform a 360-degree room and desk pan using your webcam. Please practice this before logging into the exam. You must have working speakers to communicate with the proctors. You will forfeit your exam voucher if you don't comply with the requirements.

DON'T FORGET

Your computer must be connected to a power source, and connected to reliable, high-speed internet. Please check your internet speed by going to [speedtest.net](https://www.speedtest.net) just prior to logging into the exam. Upload and download speed should be 5.0 Mbps. Do not use VPN while taking the exam, as this may cause issues connecting to the exam system.

REMEMBER YOUR VALID GOVERNMENT ISSUED ID

You are required to present a valid, government-issued photo ID (e.g., driver's license, passport, state-issued ID card) on exam day. Temporary, copies, paper, or digital IDs are NOT permitted. Ensure that your first and last name on the photo ID EXACTLY match your first and last name as they appear on your exam confirmation. Exam attempt will be forfeited if name does not match. If you have more than one last name or a suffix listed on your government-issued photo ID, the same last names must be reflected on the confirmation notice. If your name is incorrect, please contact AAPC at 800-626-2633 at least 48 hours prior to your scheduled exam date.



ID

A valid, government-issued photo ID (e.g., driver's license, passport, state-issued ID card) is required for an exam. Temporary, copies, paper, or digital IDs are NOT permitted.



External Webcam

You must position the webcam so that the proctor will be able to see your face, hands, keyboard, and the area surrounding your keyboard (about 10 inches).



Laptop OR Desktop

Your computer must pass the minimum system requirements for the online exam. You can test your computer in a few seconds any time prior to the exam. Please go to [speedtest.net](https://www.speedtest.net) to verify your upload and download are at least 5.0 Mbps.



Drink on Desk

You are permitted to have a clear water bottle or clear cup of water on your desk. The bottle or cup must be unobstructed with no items on it, such as labels, etc.

Electronic Devices

No electronic devices with an on/off switch or any device capable of capturing and storing an image are allowed into the examination room. Failure to comply will result in disqualification of your exam. This list includes, but is not limited to cell phones, tablets, smart watches, Fitbits, etc.

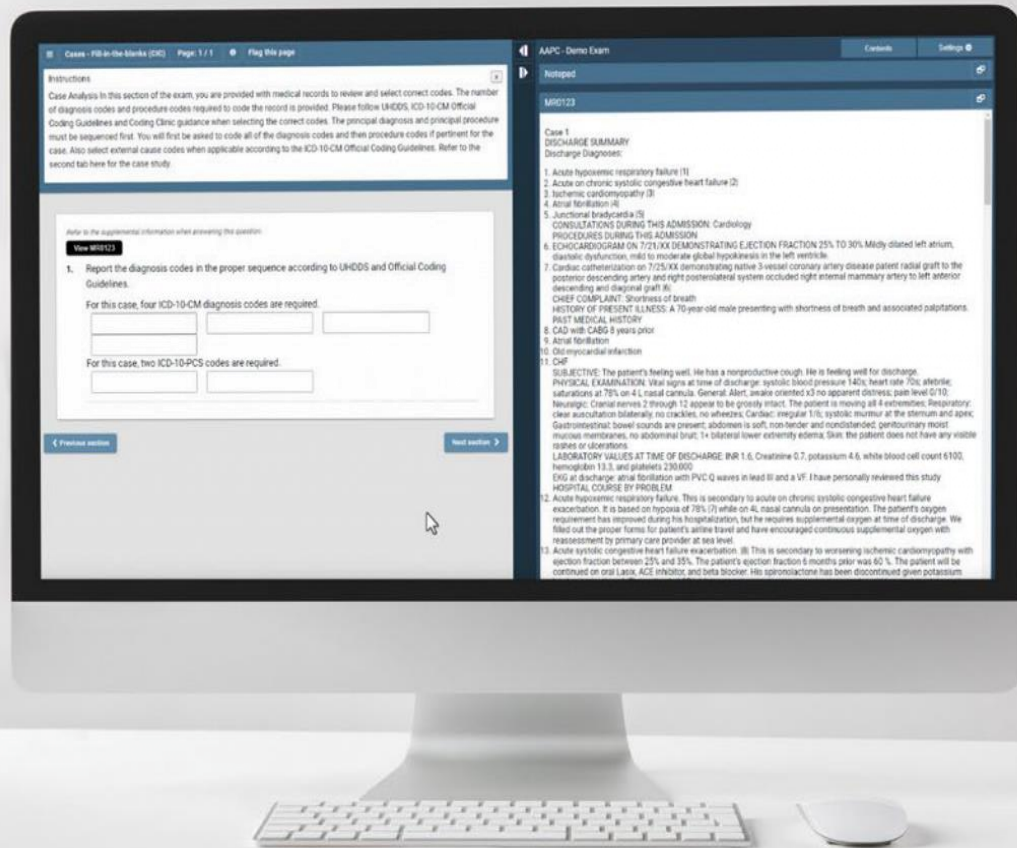
